विषयः राज्य सरकार के सिविल / पारिवारिक पेंशनरों आदि को महँगाई राहत की स्वीकृति।

अधोहस्ताक्षरी को यह कहने का निदेश हुआ है कि उपर्युक्त विषय पर वित्त विभाग के कार्यालय—ज्ञाप संख्या—सा—3—479/दस—2013—301/2000 टी०सी०, दिनाँक 29 मई, 2013 जिसके द्वारा महँगाई राहत दिनाँक 01 जनवरी, 2013 से 80 प्रतिशत स्वीकृत की गयी थी, क्रे कम में राज्यपाल महोदय द्वारा, औसत उपमोक्ता मूल्य सूचकांक में इस बीच हुई वृद्धि की प्रतिपूर्ति हेतु उक्त संदर्भित कार्यालय—ज्ञाप दिनाँक 29 मई, 2013 में उल्लिखित दरों का संशोधन करते हुए दिनाँक 01 जुलाई, 2013 से महँगाई राहत की 10 प्रतिशत की एक और किशत दिये जाने की सहर्ष स्वीकृति प्रदान की गयी है।

- 2— पेंशनरों को अनुमन्य महँगाई राहत में दिनाँक — 01 जुलाई, 2013 से 10 प्रतिशत की उपर्युक्त बढ़ोत्तरी के फलस्वरूप पेंशन पर अनुमन्य महँगाई राहत की दर 80 प्रतिशत से बढ़कर 90 प्रतिशत हो जायेगी।
- 3— महँगाई राहत की ऐसी धनराशि जो एक रूपये के आधे से कम आगणित होगी, उसे नजरअंदाज़ कर दिया जायेगा, जबिक आधे अथवा आधे से अधिक को पूर्ण रूपये के रूप में लिया जायेगा।
- 4— यह आदेश उच्च न्यायालय के न्यायाधीशों, स्थानीय निकायों तथा सार्वजनिक उपक्रम आदि के सेवकों पर लागू नहीं होंगे। उनके संबंध में संबंधित विभागों द्वारा अलग से आदेश निर्गत किया जाना अपेक्षित होगा। अखिल भारतीय सेवाओं के पेंशनरों / पारिवारिक पेंशनरों के संबंध में आदेश पृष्ठांकन संख्या—सा—3— जी०आई०—22/ दस—2013—301/2000, दिनाँक 07 अक्टूबर, 2013 द्वारा जारी किए जा चुके है।

Subject: Grant of dearness relief to State Government's civil / family pensioners.

The undersigned is directed to refer to the office memorandum No. Sa-3-479/X-2013-301/2000 T.C. dated May 29, 2013 on the above mentioned subject. sanctioning additional instalment of dearness relief with effect from January 01, 2013 and to say that the Governor is pleased to further enhance by 10 percent, with effect from July 01, 2013, the rate of dearness relief admissible to all civil / family pensioners of this Government to compensate them for the rise, in the meanwhile, in the average consumer price index.

- 2- As a consequence of the abovementioned 10 percent rise, the dearness relief payable on the pension will rise from existing 80 percent to 90 percent with effect from July 01, 2013.
- 3- In the calculation of dearness relief, fraction of a rupee less than its half shall be ignored while half or more shall be counted as one rupee.
- 4- These orders will not be applicable to the Judges of High Court, employees of local bodies and public undertakings / corporations etc. in respect of whom separate orders will be issued by respective departments. Orders in India Service respect of All family pensioners have pensioners/ been issued vide endorsement number G-3-G.I.-22/X-2013- 301/2000, dated October 07, 2013.

5— यह आदेश शिक्षा / प्राविधिक शिक्षा विभाग के अन्तर्गत राज्य निधि से सहायता प्राप्त शिक्षण संस्थाओं के ऐसे पेंशनरों, जिन्हें शासकीय पेंशनरों के समान पेंशन / पारिवारिक पेंशन अनुमन्य हैं, पर भी लागू होंगे।

6— शासन के कार्यालय-ज्ञाप संख्या-ए-1-252 / दस-10(3)-81, दिनाँक 27 अप्रैल, 1982 में निर्गत आदेशानुसार पेंशन पर अतिरिक्त राहत आदि के भुगतान के लिए महालेखाकार के प्राधिकार-पत्र की आवश्यकता नहीं है। अतः पेंशन भुगतान अधिकारियों द्वारा इस कार्यालय-ज्ञाप के आधार पर ही उपरोक्तानुसार अनुमन्य महँगाई राहत का भुगतान कर दिया जायेगा।

7— महँगाई राहत स्वीकृति करने के संबंध में अन्य शर्ते एवं प्रतिबन्ध, जो इससे संबंधित पूर्व शासनादेशों में निर्धारित हैं, पूर्ववत् लागू रहेंगे।

6- As per orders issued in O.M. No. A - 1- 252 / X- 10 (3)- 81, dated April 27, 1982 the Accountant General's authority is not necessary for payment of relief of pension and as such the payment of dearness relief shall be made by the concerned pension disbursing authorities on the basis of this office memorandum alone.

7- Other terms and conditions regarding grant of dearness relief laid down in earlier Government orders shall remain applicable as before.

OFFICE MEMORANDUM

Subject: Dearness pensioners/family pensioners - Revised rate effective from 1.7.2013.

The undersigned is directed to refer to this Department's OM No. 42/13/2012-P&PW(G) dated 2nd May, 2013 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief (DR) payable to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 80 % to 90% w.e.f. 1st July, 2013.

- These orders apply to (i) All Civilian Central Government Pensioners/Family 2. Pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners and (v) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government pensioners from Pakistan, who are Indian Nationals but receiving pension on behalf of Government of Pakistan and are in receipt of ad-hoc ex-gratia allowance of Rs. 3500/- p.m. in terms of this Department's OM No. 23/1/97-P&PW(B) dated 23.2.1998 read with this Department's OM No. 23/3/2008-P&PW(B) dated 15.9.2008.
- 3. Central Government Employees who had drawn lump sum amount on absorption in a PSU/Autonomous body and have become eligible to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount in terms of this Department's OM No. 4/59/97-P&PW (D) dated 14.07.1998 will also be entitled to the payment of DR @ 90% w.e.f. 1,7,2013 on full pension i.e. the revised pension which the absorbed employee would have received on the date of restoration had he not drawn ump sum payment on absorption and Dearness Pension subject to fulfillment of the conditions laid down in para 5 of the O.M. dated 14.07.98. In this connection, nstructions contained in this Department's OM No.4/29/99-P&PW (D) dated. 12.7.2000 efer.

Payment of DR involving a fraction of a rupee shall be rounded off to the next gher rupee.

- 5. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended vide this Department's OM No. F. No. 38/88/2008-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension, will remain unchanged.
- 6. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 7. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 8. The offices of Accountant General and Authorised Public Sector Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 9. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C&AG.
- 10. This issues with the concurrence of Ministry of Finance, Department of Expenditure conveyed vide their OM No. 1(4)/EV/2004 dt. 01st Oct, 2013.
