Sub:- Revision of pension of pre-1.1.2006 pensioner/family pensioner of

i) Principal and Lecturer holding pay structure of A.I.C.T.E as per G.O. no.574-TET(Poly) dated

13/9/2010of Govt.Sponsored Polytechnic

ii) the employees under Government Sponsored Polytechnic(except Principal,Lecturer and other categories of staff covered by recommendation of the A.I.C.T.E.)

Sir,

It is informed that pursuant to the recommendation of 5th Pay Commission, Govt. of West Bengal, Department of Technical Education & Training, Polytechnic Branch in their Memo. No. 996-TET(Poly)/4E-03-2011dated 18/12/2012 & Memo No.1000-TET(Poly)/4E-03/2011 dated 18/12/2012 have sanctioned revised rates of pension/family pension with effect from 1.4.2008 respectively to the employees and Principal & Lecturer of Govt. Sponsored Polytechnic, who retired/died in harness prior to 1.1.2006 as an extension of benefit of G.O. No. 73-SE(B) dated 19/05/2009(circulated vide No.Pen.Co-ordn/111/Vol-V/259/Vol-II/81 dated 2/9/2009) issued by the Govt. of West Bengal, School Education Department as described below:-

- i) The pension/family pension of existing pre-2006 pensioners/family pensioners will be consolidated with effect from 1/1/2006 by adding together
 - a) The existing pension/family pension;
 - b) Dearness pension, where applicable, @50% of basic pension/family pension on notional basis
 - c) Dearness Relief upto AICP(IW) average index 536(base year 1982=100,i.e. @ 24% of basic pension/basic family pension plus dearness pension 50% of basic pension/basic family pension where applicable, on notional basis
 - d) Fitment weightage @40% of the existing pension/family pension

pension notionally with effect from 1/1/2006 with actual effect from 1/4/2008.

ii) The minimum consolidated pension/family pension of above categories of pensioner/family pensioner will be Rs. 3300/- p.m. with effect from 1/4/2008. In case of pensioners who are in receipt of more than one pension, the service pension shall be

stepped up to Rs.3,300/-,if it falls below Rs.3,300/- after consolidation. Other pension will simply be consolidated and it will not be stepped up ,if it falls below Rs.3,300/- .

- iii) The upper ceiling of pension and family pension has been increased from Rs.6750/-and Rs.4050/- to Rs.22,950/- and Rs.13,770/- respectively for the category of employees. Similarly, the upper ceiling of pension and family pension has been increased from Rs.10000/-and Rs.4050/- to Rs.35,000/- and Rs.21,000/- respectively for the category of Principal/Lecturer.
- iv) The benefit of additional pension/family pension will be admissible to the old pensioner/family pensioner at the rate given below in addition to his/her basic pension/family pension. However, the provision as contained in G.O. No. 191-F(Pen) dated 16/4/2012 (circulated vide No.Pen.Co-ordn/300/Vol-II/51/Vol-V/111/Vol-VI/50 dated 25/5/2012) that when a pensioner receives family pension along with his own service pension, the additional amount of pension for attaining the age of 80 years and above will be admissible only on service pension, is to be followed in this regard.

Age of Pensioners	Additional Quantum of Pension
From 80 years to less than 85 years	20% of revised basic pension/family pension
From 85 years to less than 90 years	30% of revised basic pension/family pension
From 90 years to less than 95 years	40% of revised basic pension/family pension
From 95 years to less than 100 years	50% of revised basic pension/family pension
100 years or more	100% of revised basic pension/family pension

- v) In case of re-employed/employed pensioner/family pensioner, who are not getting dearness relief, the consolidation of pension/family pension as mentioned in (i) above will have to be made taking into account of notional dearness relief that would have been admissible but for their re-employment/employment, as if they are drawing dearness relief. However, dearness relief beyond 1/4/2008 will not be admissible to them.
- 2. Besides, it is informed that the Department of Technical Education & Training Polytechnic Branch in their Memo. No. 1331-TET(Poly)4E-03/2011(Pt) dated 18/12/2013 received through letter No.10-TET(Poly) dated 3/1/2014 have also sanctioned revised rates of Dearness

Relief to the categories of pre-1/1/2006 pensioners /family pensioners whose pension /family pension has been revised in terms of Memo. No. 996-TET(Poly)/4E-03-2011 and Memo No.1000-TET(Poly)/4E-03/2011 both dated 18/12/2012 as well as such categories of post 1/1/2006 pensioners /family pensioners whose pension/family pension has been regulated under Memo No.998-TET(Poly) & 1002-TET(Poly) both dated 18/12/2012 as below:-

Period for which payable	Rates of Dearness Relief per month on revised pension/family pension
01/04/2008 to 31/05/2008	2%
01/06/2008 to31/10/2008	6%
01/11/2008 to28/02/2009	9%
01/03/2009 to 31/03/2009	12%
01/04/2009 to 30/11/2009	16%
01/12/2009 to 31/03/2010	22%
01/04/2010 to 30/11/2010	27%
01/12/2010 to 31/12/2011	35%
01/01/2012 to 31/12/2012	45%
01/01/2013 to 31/12/2013	52%
01/01/2014 onwards	58%

Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Further rates of dearness relief for such categories of pensioner/family pensioner will be at par with the rates as sanctioned by the Administrative Department for the State Aided Non-Govt. Educational Institutions from time to time for their pensioners/family pensioners.

3. All Pension Disbursing Officers are, therefore, requested to arrange revision of pension/family pension to the categories of pensioners/family pensioners who retired/died in harness prior to 1/1/2006 in terms of the Memo No. 73-SE(B)) dated 19/5/2009, keeping in view of the instruction given above and to make payment thereof with effect from 1/4/2008 along with dearness relief at the rates mentioned above, subject to adjustment of all payments made in this regard.
