Subject: Grant of Dearness Relief on pension to the Pensioners/Family Pensioners of the Teaching & Non-Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West Bengal with effect from 1-12-2010 & 1-1-2012.

In continuation to this office Circular No. Pen. Co-ordn./111/Vol.V/259 Vol. II/196 dated. 29.3.2010, it is stated that Govt. of West Bengal, School Education Department., Budget Branch in their Memo No.s 9-SE(P&B)/5B-37/09 dt.11.1.2011 and Memo No. 12-SE(P&B)/5B-51/2004 dt.11.1.2012 have sanctioned Dearness Relief @35% and @45% of basic pension/family pension with effect from 01-12-2010 & 1-1.2012 respectively for the Pensioners/Family Pensioners of the teaching and non-teaching employees of Non-Govt. Aided/Sponsored Educational Institution etc.

The benefit is applicable for the pensioners/family pensioners who are drawing pension/family pension under the scheme D.C.R.B.1981 of West Bengal Non-Govt./Sponsored/Aided Educational Institutions (Primary & Secondary), as well as the pensioners/ family pensioners who retired/died prior to 01-04-1981 **excluding** D.A. getting Institutions, and are governed under GO No. 163-Edn(B) dated 15-06-1990 and GO No. 341-Edn(B) dated 26-11-1993 read with Memo. No 73-SE(B),dated 19.5.2009.

Payment of Relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of relief to pensioners/family pensioners, such as, regulation of relief on pension/family pension during employment/re-employment, regulation of relief where more than one pension is drawn etc., as contained in Finance Department's Memo No. 7533-F dated 06-07-1988 will remain unchanged.

All Pension Disbursing Authorities are, therefore, requested to make necessary arrangements for payment of Dearness Relief @35% and @45% with effect from. 01-12-2010 and 1-1-2012 respectively on revised basic pension Pension/Family Pension to the above categories of Pensioners/Family Pensioners whose pension/family pension has been revised as per recommendations of the 5th pay commission, subject to proper adjustment.
