Subject : Grant of Domestic Help Allowance with effect from 01-11-1999 and  
01-08-2010 and Medical Allowance with effect from 01-08-  
2010 to the retired Judicial Officers of Govt. of Bihar.

This is to state that the Govt. of Bihar in their FD Resolution No. 3A2-Be.Pu.-  
12/2009 (Vol-II) - 14301 dated 22-12-2010 have enhanced the rate of Domestic Help  
Allowance @ ₹2500/- (Rupees Two thousand and five hundred) only per month with effect  
from 01-08-2010 in respect of retired officers of Bihar Judicial Service, from their existing  
rate of ₹1250/- (Rupees One thousand two hundred and fifty) only per month with effect  
from 01-11-1999 sanctioned in their Resolution No. 13070 dated 26-12-2006. Domestic Help  
Allowance @ ₹1000/- (Rupees One thousand) only per month shall be admissible to the  
family pensioners of Judicial Service with effect from 01-08-2010.

2. Besides, Govt. of Bihar in their FD Resolution No. 3A2-Be.Pu.-12/2009 (Vol-II) -  
14302 dated 22-12-2010 have sanctioned Medical Allowance @ ₹1500/- (Rupees One  
thousand and five hundred) only per month to such pensioners and @ ₹750/- (Rupees seven  
hundred and fifty) only per month to the family pensioners with effect from 01-08-2010.

3. Having been authorised by the Accountant General (A&E)-II, Bihar in their  
letter Nos. Pen-IX-Spl. Seal Authority No. 89 dated 09-05-2007 and Pen-IX-Spl. Seal  
Authority No. 1701 dated 07-01-2011, it is requested to make necessary arrangements for  
payment of Domestic Help Allowance and Medical Allowance to the retired Judicial  
Officers of Govt. of Bihar and family pensioners as per instructions laid down above.

4. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Govt. of  
Bihar etc."
