Co-ordn. /65 Vol. IV/149 GNO Subject: Payment of Dearness Relief at the enhanced rate w.e.f. 01-07-2013 to the retired Judicial Officers of the State of West Bengal whose pension has been revised as per recommendation of Padmanabhan Committee. In continuation to this office circular 200 Pen.Co-ordn./65 Vol.IV/43 dated 31/05/2013, it is stated that the Government of West Bengal, Judicial Department in their letter No 5060-J dated 18/11/2013 has sanctioned enhancement of the rates of dearness relief from 80% to 90% with effect from 01/07/2013 for their retired Judicial Officers/family pensioners (whose pension/family pension has been revised in terms of G.O. No 7014 - J and G.O No 7012 - J both dated 25/10/2010). Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee. All Pension Disbursing Authorities including Public Sector Banks are requested to make necessary arrangements for payment of dearness relief at the revised rate i.e. @ 90% with effect from 01/07/2013 to the above mentioned categories of pensioners/family pensioners after making proper adjustment of payment already made.
