Subject: Grant of dearness relief to Post-1/1/2006 pensioners of D.A. Getting Institutions.

It is informed that Govt. of West Bengal in their School Education Department, Secondary. Branch order No. 3228-SE(S) dated 04.10.2012 have sanctioned new rates of dearness relief, in replacement of the previous orders, to the pensioners (both teaching and non-teaching employees) of D.A. Getting Institutions who retired on or after 01/01/2006 and are in receipt of revised pay as per West Bengal Non-Govt Aided Educational Institution ROPA, 2009 and whose pension have been revised/regulated in terms of G.O.No. 72-SE(B) dated 19.05.2009.

The new rates of Dearness Relief as sanctioned are as below :-

Period for which payable	Rates of Dearness Relief p.m.
01.04.2008 to 31.05.2008	2%
01.06.2008 to 31.10.2008	6%
01.11.2008 to 28.02.2009	9%
01.03.2009 to 31.03.2009	12%
01.04.2009 to 30.11.2009	16%
01.12.2009 to 31.03.2010	22%
01.04.2010 to 30.11.2010	27%
01.12.2010 to 31.12. 2011	35%
01.01.2012 onwards	45%

Accordingly, all Pension Disbursing Authorities are requested to make necessary arrangements for payment of dearness relief on pension at such rates as mentioned above to those pensioners after proper adjustment of payment, if any, made to such pensioners.

To facilitate identification of such category of pensioners, P.P.O/Revised Authority for such pensioners are being issued from this office with the recording therein as - 'Post-2006 D.A. Getting Pensioners, Pay as per ROPA, 2009, Pension regulated under Memo. No. 72-SE(B) dated 19.05.2009' in their Pension Payment Order issued by this office and until further communication, the above rates of dearness relief may be paid, only to such category of pensioners. For the other category of pensioners of D.A. Getting Institutions, the existing rate as contained in this office circular No. Pen. Co-ordn/111Vol. VI/216 dated 24-1-2012 will remain in force until further communication.

Payment of dearness relief involving a faction of a rupee shall be rounded off to the next higher rupee.

Other provisions relating to grant of dearness relief on pension, as applicable to State Govt. pensioners, will also apply mutatis mutandis.
