Subject:- **Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission for the year 2016**

Govt. of West Bengal, Higher Education Department., C.S. Branch in their Memo No. 1177-Edn(CS)/1P-20/98(Pt.1) dated 29/12/2016 have sanctioned payment of ex-gratia grant of Rs.1800/- (Rupees one thousand eight hundred) only in lump per head to all pensioners / family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission including the holders of provisional pension who retired prior to 30.09.2015 and also the pensioners who retired or died after 30.09.2015 but prior to 01.09.2016 and are not eligible to receive ad-hoc bonus.

2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with relief as on 31<sup>st</sup> March 2016 did not exceed Rs.25000/-(Rupees twenty five thousand). The benefit is not admissible to those who are entitled to ad-hoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.

3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.1800/- (Rupees One thousand eight hundred) only to the above categories of pensioners / family pensioners keeping in view the instructions as mentioned above.

4. The charges on this account is debitable to the Head "2071-Pension and other retirement benefits 01-Civil-800-Other Expenditure".

5. In case of any doubt/difficulty, the matter may be referred to this office for clarification.

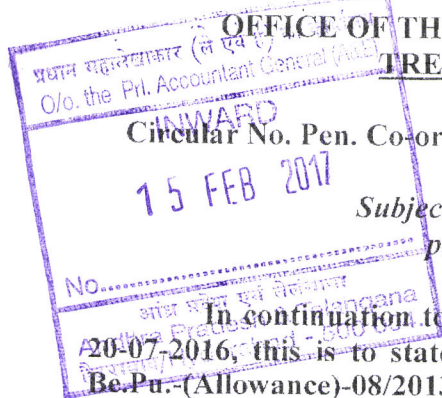

Subject : Grant of Dearness Relief to the Bihar Government pensioners/family pensioners with effect from 01-07-2016.

In continuation to this office circular No. Pen. Co-ordn./Bihar/Vol.- VIII/DR/68 dated 20-07-2016, this is to state that the Government of Bihar in their FD Resolution No. 3A-2-Be.Pu.-(Allowance)-08/2013-9386/B. dated 09-12-2016 has sanctioned dearness relief to their pensioners/family pensioners whose pension have been revised in the light of Bihar Government F D Resolution No. B.-27/Pay Co.-137/2008-819 and 820 both dated 23-09-2009 at the rate and from the date as under :-

Date of effect	Rate of Dearness Relief per month
01-07-2016	132% of basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction less than 50 paise may be ignored.

3. Dearness relief will not be admissible to the re-employed pensioners. Excepting that, dearness relief will be admissible to the rest of the civil pensioners who are getting compensatory pension, old age pension, retiring pension and invalid pension. This relief is also admissible to the pensioners getting provisional pension/family pension and extra ordinary pension.

4. So far as application of this order in respect of the retired employees of the High Court/Bihar Legislative Assembly/Bihar Legislative Council is concerned, necessary orders will be issued separately by the respective secretariat/office after obtaining the concurrence of the Chief Justice, Patna High Court/Speaker, Bihar Legislative Assembly/Chairman, Bihar Legislative Council, Bihar, Patna.

5. Incidentally, it may be mentioned that this circular is issued to other Accountants General just to remind them the applicability of this order to the West Bengal Government pensioners/family pensioners guided by Bihar Pension Rules.

6. Having been authorised by the Accountant General (A&E), Bihar in their letter No. Pen-IX-Spl. Seal Authority No. 140 dated 26-12-2016, received with special seal and signature on 01-07-2016, it is requested to make necessary arrangements for payment of dearness relief @ 132% with effect from 01-07-2016 to all eligible Bihar Government pensioners/family pensioners as well as West Bengal Government pensioners/family pensioners guided by Bihar Pension Rules on their revised pension/family pension mentioned above after proper adjustment.

8. The charges on this account for the pensioners/family pensioners of Government of Bihar are debitable to the Government of Bihar under the head "8793-I.S.S.A/cs.; Government of Bihar etc." and the charges for the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules are debitable to the Government of West Bengal under the head "2071-Pension and Other Retirement Benefits".
