Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission for the year 2015

8 72 6 Govt. of West Bengal, Higher Education Department., C.S. Branch in their Memo No. 1098-Edn(CS)/1P-20/98(Pt.1) dated 1/12/2015 have sanctioned payment of exgratia grant of Rs.1700/- (Rupees one thousand seven hundred) only in lump per head to all pensioners / family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission including the holders of provisional pension who retired prior to 30.09.2014 and also the pensioners who retired or died after 30.09.2014 but prior to 01.09.2015 and are not eligible to receive adhoc bonus.

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension alongwith relief as on 31st March 2015 did not exceed Rs.24000/-(Rupees twenty four thousand). The benefit is not admissible to those who are entitled to adhoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow exgratia grant @ Rs.1700/- (Rupees One thousand seven hundred) only to the above categories of pensioners / family pensioners keeping in view the instructions as mentioned above.
- 4. The charges on this account is debitable to the Head "2071-Pension and other retirement benefits 01-Civil-800-Other Expenditure".
- 5. In case of any-doubt/difficulty, the matter may be referred to this office for clarification.
