Sub : Grant of ex-gratia payment to the pensioner/family pensioners of the teaching and non teaching employees of Non-Govt. Aided/Sponsored Educational Institution under DCRB' 81 scheme for the year 2011.

It is informed that the Govt. of West Bengal, School Education Department, Budget Branch in their Memo no. 320-SE(B)(P&B)/5B-19/2011 dated 9/9/2011(since received through their letter No. 516-SE(P&B)/5B-19/2011 dated 11/12/2012) have sanctioned exgratia grant of ₹800/- (**Rupees eight hundred**) only in lump per head to all pensioners/family pensioners of the teaching and non teaching employees of Non Govt. Aided/Sponsored Educational Institution guided under DCRB' 81 scheme (excluding DA Getting Schools and Sanskrit Tolls) including the holders of provisional pension who **retired/died prior to 30-9-2010** and also the pensioners/family pensioners who **retired or died after 30.09.2010 but prior to 1-9-2011** and are not eligible to receive adhoc bonus.

2. The above categories of pensioners/family pensioners whose basic pension/family pension plus relief on pension as on March 31, 2011 did not exceed ₹20,000/-(Rupees twenty thousand) are only entitled to get this benefit .

3. This benefit is also admissible to the pensioner/family pensioner of Non Govt./ Sponsored/Aided/ Educational Institution (Pry. & Secondary) who retired/died prior to 1-4-81 and are governed under GO no. 163-Edn(B), dt. 15-6-90 and GO no. 341-Edn(B), dt. 26-11-93.

4. All Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Ex-gratia grant of Rs.800/- (Rupees eight hundred) only in lump for the year 2011 to the above categories of pensioners/family pensioners subject to fulfillment of above conditions.

5. The charges are debitable to the head 2071-Pen. and other retirement benefit- 01-Civil 109-Pension to Employees of State Aided Educational Institutions, during the current financial year.
