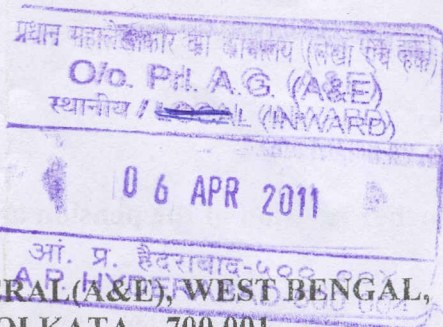

Sub:- Further revision of the pension of the pre-1.1.2006 pensioners of D.A. Getting School

In supercession of this office circular No. Pen.Co-ordn/111/Vol-V/80 dated 2.9.2009, it is stated that the Govt. of West Bengal, School Education Department, Budget Branch in their Memo. No.29-SE (B) dated 28.2.2011 have sanctioned 20% increase in their existing pension notionally w.e.f. 1.1.2006 and with actual effect from 1.4.2008 after modifying the provisions as contained in rule 2(ii) of Memo. No. 72-SE(B) dated 19.5.2009 issued by the School Education Department. However, the existing rates of minimum monthly pension @ ₹ 1650/- per month will remain unchanged.

In order to facilitate payment of revised pension as above to this category of pensioners, three illustrations showing the mode of calculation of revised pension are given below:-

i) Existing Pension before 1.1.2006 - ₹ 650/-
Increase 20% - ₹ 130/-
Total - ₹ 780/-

It should be stepped up to ₹1650/-p.m. w.e.f. 1.1.2006(notionally).He is entitled to get revised pension ₹1650/-p.m. actually w.e.f.1.4.2008.

ii) Existing Pension before 1.1.2006-₹1450/-
Increase 20% -₹ 290/-
Total -₹1740/-


He is entitled to get revised pension ₹1740/- p.m. (notionally 1.1.2006) actually with effect 1.4.2008

iii) Existing Pension before 1.1.2006-₹1750/-
Increase 20% -₹ 350/-
Total ₹2100/-

He is entitled to get revised pension ₹2100/- p.m.(notionally 1.1.2006) actually with effect 1.4.2008

These above categories of pensioners are also entitled to get dearness relief @ 79% w.e.f. 1.4.2008, @ 85% w.e.f. 1.6.2008, @ 91% w.e.f. 1.11.2008, @ 97% w.e.f 1.3.2009, @ 104% w.e.f.1.4.2009 on their revised pension arrived at in terms of this circular.

All Pension Disbursing Authorities are ,therefore, requested to make necessary arrangements for immediate payment of revised pension with effect from 1.4.2008 alongwith dearness relief as mentioned above (sanctioned by the School Education Department from time to time) after proper adjustment.
