

**Subject: Grant of Dearness Relief on pension to the Pensioners/Family Pensioners of the Teaching & Non-Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West Bengal with effect from 01/04/2010 to 30/11/2010**


It is informed that Govt. of West Bengal, School Education Department., Budget Branch in their Memo No.449-SE(P&B)/5B-51/2004 dated 4/10/2012 have since approved allowing on post facto basis payment of Dearness Relief @ 27% of basic pension/family pension with effect from 01/04/2010 to 30/11/2010 (i.e. upto the date after which the subsequent rate of Dearness Relief @ 35% came into effect and circulated under this office Circular No. Pen. Co-ordn./111/Vol.VI/259/Vol-II/88 dated 09/07/2012 issued on the basis of School Education Department Memo No. 9-SE(P&B)/5B-37/2009 dated 11/1/2011) to the Pensioners/Family Pensioners of the teaching and non-teaching employees of Non-Govt. Aided/Sponsored Educational Institution etc.

The benefit is admissible to the pensioners/family pensioners who are drawing pension/family pension under West Bengal Non-Govt./Sponsored/Aided Educational Institutions (Primary & Secondary), D.C.R.B. 1981 Scheme as well as the pensioners/family pensioners who retired/died prior to 01/04/1981 (**excluding** D.A. getting Institutions) and are governed under GO No. 163-Edn(B) dated 15-06-1990 and GO No. 341-Edn(B) dated 26-11-1993 read with Memo. No 73-SE(B),dated 19.5.2009.

Payment of Relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of relief to pensioners/family pensioners, such as, regulation of relief on pension/family pension during employment/re-employment, regulation of relief where more than one pension is drawn etc., as contained in Finance Department's Memo No. 7533-F dated 06-07-1988 will remain unchanged.

All Pension Disbursing Authorities are, therefore, requested to make necessary arrangements for payment of Dearness Relief @ 27% to the above mentioned categories of pensioners/family pensioners on their revised basic pension Pension/Family Pension for the period 01/04/2010 to 30/11/2010, after making necessary adjustment of dearness relief already paid during that period,
