F. 42/15/2011-P&PW(G) dated 29<sup>th</sup> March, 2011 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the State Government Pensioners/Family Pensioners shall be enhanced from the existing rate of **45% to 51%** with effect from 01-01-2011.
