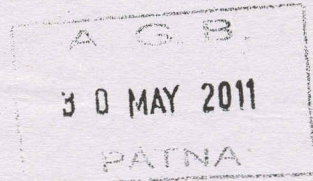

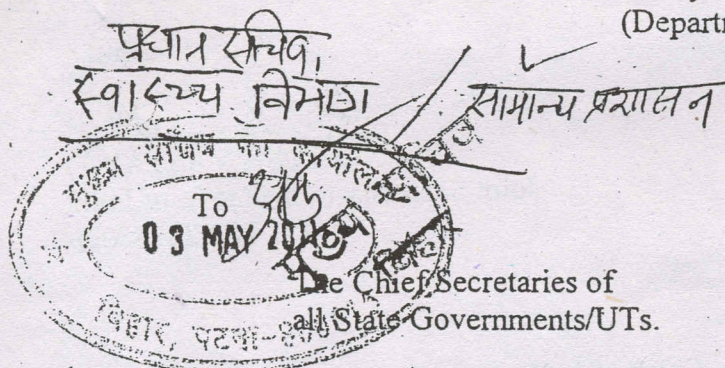

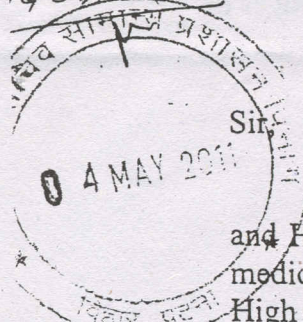

Subject: Extension of medical facilities to a High Court Judge retiring from the
High Court of a State and settling down in another State/UT.



I am directed to say that the Association of Retired Judges of Supreme Court and High Courts of India has invited attention of this Department to the difficulties in medical treatment, being faced by some Judges of High Courts who retired from the High Court of one State and settled down in some other States.

2. In this regard, Section 23D of the High Court Judges (Salaries and Conditions of Service) Act, 1954 provides that:

- (1) Every retired Judge shall, with effect from the date on which the High Court Judges (conditions of Service) Amendment Act, 1976, receives the assent of the President be entitled, for himself and his family, to the same facilities as respects medical treatment and on the same conditions as retired officers of the Central Civil Services, Class I and his family, are entitled under any rules and orders of the Central Government for the time being in force.
- (2) Notwithstanding anything in sub-section (1) but subject to such conditions and restrictions as the Central Government may impose a retired Judge of the High Court for the State may avail, for himself and his family, any facilities for medical treatment which the Government of that State may extend to him.

3. Under sub-section (1) above, the Ministry of Health & Family Welfare have extended the benefits of Central Government Health Scheme (CGHS) to the retired Judges of High Courts who are residing in CGHS covered areas. Under sub-section (2) above, no conditions or restrictions has been imposed by the Central Government. In fact, this Department has, vide letter No.24/12/88- Jus. dated 14.12.1989 (copy enclosed), written to all State Governments for providing medical facilities to the retired Judges and many State Governments have been doing so.



Subject: Extension of medical facilities to a High Court Judge
retiring from the High Court of a State and settling
down in another State/UT

Sir,

I am directed to refer to sub-section (1) of Section 23D of the High Court Judges (Conditions of Service) Act, 1954 which provides that a retired High Court Judge is entitled to avail himself of the same facilities as regards medical treatment and on the same conditions as a retired officer of the Central Civil Services, Class I is entitled to under extant rules and orders of the Central Government. Accordingly, retired High Court Judges are availing themselves of the medical facilities available under the Central Government Health Scheme wherever it is in force.

2. Sub-section (2) of the aforesaid section provides that, subject to such conditions and restrictions as the Central Government may impose, a retired High Court Judge of a State and his family may avail themselves of any facilities for medical treatment which the State Government extend to them. By this Department's letter No. 24/19/79-Jus, dated 15th May, 1980, the State Governments have been requested to extend medical facilities to retired Judges in terms of the above provision wherever, Central Government Health Scheme facilities are not available.

3. It has been brought to the notice of this Department that some Judges of High Court who retired from the High Court of one State and settled down in some other State are facing considerable difficulties in getting the facilities for medical treatment in the States where they have settled down. This is especially the case with those Judges who are posted/ transferred out of their home States.

4. In view of the above, I am directed to request the State Governments/UT Administrations to consider providing medical facilities to those Judges who retire from the High Court of one State and settle down in another State after retirement if those places are not covered by Central Government Health Scheme.

5. Action taken in the matter may please be intimated to this Department.
