Subject: - Ad-hoc ex-gratia allowance to the Burma Civil Pensioners/Family

Sir/Madam,

This office has made a reference to the Ministry of Personnel, PG &Pension (Department of Pensions and Pensioners Welfare) requesting them to clarify whether benefit of Ad-hoc ex-gratia allowance can be extended to other family members of Burma Civil Pensioners(other than widow/widower). Ministry has now clarified vide letter No. 23/1/08-P&PW (B) dated 07-10-2011(copy enclosed) that the term family is confined to widow/widower and the family in case of ex-Burma Civil Pensioners has no connection with the definition of family in Rule 54 of CCS (Pension) Rules, 1972. Therefore, sanction of Ad-hoc ex-gratia allowance to the family of Burma Civil Pensioners may be regulated accordingly and Ad-hoc exgratia allowance already authorized in favour of other members of family (other than widow/widower), if any, may be stopped forthwith.
