Resolution

Under rules-77, 78 and 79 of Gujarat Civil Services (Pension) Rules, 2002, Government, after considering the merit of each case, grants compassionate pension to the employees who were retired compulsorily or dismissed from the services of the Government, if they make such request. Under the resolution cited at (1) above, minimum amount of the Compassionate Pension has been fixed at ₹ 1275/-.

2. With the implementation of the Sixth Pay Commission, the minimum amount of pension has been raised from ₹ 1275/- to ₹ 3500/- by the Government vide the resolution, Finance Department dated 13-4-2009. The matter of extending this benefit even to the pensioners availing compassionate pension was under consideration of the Government. After careful consideration, Government hereby decides to grant the benefit of minimum pension of ₹ 3500/- even to the pensioners availing compassionate pension under Gujarat Civil Services (Pension) Rules, 2002.

These orders shall come into force from 1-1-2006. The payment of the amount of difference shall be made as per the resolution, Finance Department cited at no.3 above and the provisions made thereunder from time to time.

Regarding information of birth date in the context of paying additional pension to the pensioners above the age of 80 years.

As per the resolution dated 05/05/09 cited above, in the wake of the Sixth Pay Commission, Pensioners/family pensioners who have retired - before 01/01/06 and who have crossed 80 years of age and whose date of birth could not be verified due to lack of information, are required to furnish information of their respective birth dates under the prescribed procedure to the concerned office. Family pensioners are required to furnish such information - with evidence -to their original office, which would then forward such information to the pension paying office. This may cause a great deal of problems in ascertaining availability of such information about the pensioners in their original office as well as the availability of original records with the pensioners themselves. In order to simplify this procedure, it was under consideration of the Government to decide as to which record / document should be considered acceptable as the evidence of date of birth and what provision should be made to authorize the

District Treasury Officer/ Pension Paying Officer to rectify the record, under intimation to the original office, on the basis of any of such prescribed documents.

RESOLUTION

After careful consideration, Government hereby takes the decision to recognize following documents as acceptable record/documents of the date of birth.

- (1) Certificate of date of birth, issued by a competent officer (attach affidavit if the name of the person is not clear)
- (2) Passport
- (3) Driving License
- (4) School Leaving Certificate
- (5) PAN Card
- (6) Election Photo Identity Card (if only the date of issuance has been mentioned on the card, the age from the date of issuance should be deducted to arrive at the date of birth)
- (7) Identity Card bearing date of birth, issued under any of the Central or State Scheme.
- (8) Identity Card bearing date of birth, issued under any of the autonomous body of the central or State Government.

If a pensioner/family pensioner is unable to submit any of the above mentioned documents and claims additional pension on the basis of any other reliable proof/ document, such cases shall be submitted to the administrative department and if the administrative department finds it satisfactory, pension may be sanctioned to the person. Decision of the administrative department shall be final.

The above relaxation in provision of Rule-40(e) of the Gujarat State Service (General Conditions of the Services) Rules, 2002, is given only for the purpose of payment of additional pension to the pensioners above the age of 80 years.

District Treasury Officers /Pension Paying Officers are authorized to rectify records and initiate further ancillary proceedings under intimation to the officers empowered to approve above mentioned documents.
