## Preamble:-

In G.O. dated 09.12.2010 read at (1) above the rates of D.A. was increased from 137% to 153% of the basic pension/family pension w.e.f. 1.7.2010 to the retired teaching staff who were drawing pay in the 1996 AICTE pay scales and who retired on or after 01.07.2005.

In G.O. dated 7.3.2011 read at (2) above the 2006 revised AICTE pay scales has been extended w.e.f. 1.1.2006 to the teaching cadres of the Government, aided and University Engineering colleges who were drawing pay in the AICTE pay scales. Hence Government has examined to regularise the rates of D.A w.e.f. 1.1.2006 of the teaching and equivalent cadres who were drawing immediately before retirement 2006 revised AICTE pay scales and who retired or died while in service, on or after 1.1.2006 and has ordered as below:-

### Preamble:-

In the Government Order . dated 09.12.2010 read at (1) above the rates of D.A. was increased from 137% to 153% of the basic pension/family pension w.e.f. 1<sup>st</sup> July 2010 to the retired teaching staff who were drawing pay in the 1996 AICTE pay scales and who retired on or after 01.07.2005.

In the G.O. dated 19.05.2011 read at (2) above the rates of D.A. has been regularised w.e.f. 1.1.2006 and sanction was given to increase the rates of D.A w.e.f. 1.1.2011 from 45% to 51% of the basic pension to the teaching and equivalent cadres who were drawing pay in the revised 2006 AICTE pay scales and who retired or died on or after 01.01.2006.

In G.O. dated 29.04.2011 read at (3) above the rates of D.A. to the teaching staff who are on pre-revised AICTE pay scales was increased from 153% to 166% of basic pay w.e.f. from 1.1.2011.

As per the G.O. dated 19.04.2011 read at (4) above the rates of D.A. to the teaching staff in the revised 2006 AICTE pay scales is admissible at 51% from 1.4.2011. Hence the rates of D.A of the pensioners/family pensioners of the teaching cadres who were drawing pay in the pre-revised AICTE pay scales and retired or died while in service is revised from 1.1.2011 as below:-

## GOVERNMPENT ORDER NO.FD (Spl) 126 PEN 2011(II) BANGALOROE, DATED 19<sup>th</sup> MAY 2011.

Government is pleased to sanction increase in the rates of D.A from 153% to 166% of the basic pension/family pension w.e.f. 1<sup>st</sup> January 2011 of the pensioners/family pensioners of the teaching cadre, who were drawing before retirement pay in the pre-revised AICTE pay scales and the retired or died while in service.

As per G.O. dated 19.05.2011(I) read at (2) above the rates of D.A shall be 51% w.e.f.1.4.2011 of the pensioners/family pensioners who were before retirement drawing pay in the revised 2006 AICTE pay scales of the teaching cadres.

The payment on account of the increase in D.A. as per this order involving fractions of 50 paise and above shall be rounded of the next rupee and fractions less than 50 paise shall be ignored.
