Sub: Grant of Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners for the year 2010-11

Government of Kerala, as per GO(P) No.370/2011/Fin dated 27.8.2011 as modified as per GO(P) No.378/2011/Fin dated 2.9.2011 have sanctioned Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners at the rates mentioned below:

Category	Rate of Special Festival Allowance
Service pensioners	Rs.550
Family pensioners	Rs.450
Pro-rata pensioners	Rs.500
Ex-gratia pensioners	Rs.450
Personal Staff Pensioners	Rs.450
Retired Leprosy Patient Employees	Rs.450
Part-time Contingent Pensioners	Rs.450
Part-time Contingent Family pensioners	Rs.400

This allowance is admissible to those pensioners:

- 1. whose pension commenced from a date prior to 1.4.2010 and
 - 2. whose pension commenced after 1.4.2010 but are not eligible for bonus or such other allowances as per the above Government Order for want of 6 months continuous service during the financial year 2010-2011. In their case, a self declaration to the effect that they are not eligible for bonus or special festival allowance by virtue of their service during 2010-11 may be insisted upon before arranging payment.

Those who are drawing compassionate allowance shall be paid compassionate allowance at the rate of Rs.550 as they are treated in par with Service pensioners.

The allowance sanctioned as per these orders shall be disbursed to the eligible Pensioners/Family Pensioners before 31.3.2012.

If a Service Pensioner is also in receipt of family pension, the special festival allowance is payable only on the basis of one of those pensions.

The special festival allowance sanctioned as per these orders is admissible to all State Pensioners/Family Pensioners except to the following categories.

- 1. All India Pensioners/Family Pensioners The Market Marke
- 2. Re-employed pensioners
- 3. Employed Family Pensioners
