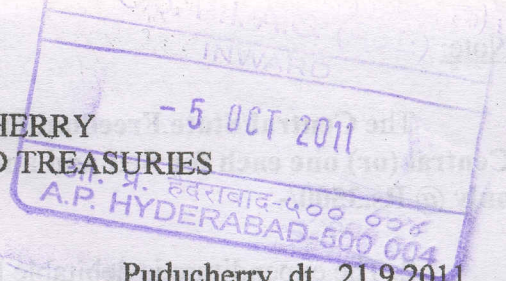

The Central/State Freedom Fighters drawing two pensions one each for State and another Central (or) one each for Self and another family/dependent pension are entitled for one payment only @ Rs.3500/-
