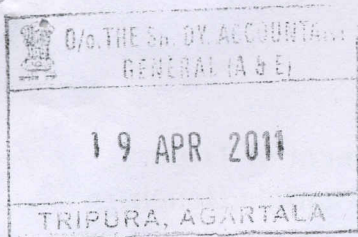

The undersigned is directed to enclose herewith a copy of the Office Memorandum No.F.1(2)-2011-E-II(B) dated 24th March, 2011 of Department of Expenditure, Ministry of Finance, Government of India regarding release of DA to the Central employees at revised rates effective from 01-01-2011 and mode of payment thereof.

All Heads of Departments / Heads of Offices are therefore, requested to arrange payment of DA as per the enhanced rates from 45% to 51% with effect from 1st January, 2011 to the officers belonging to MT Cadres of All India Services Officers and other Central Government employees working on deputation under this State Government of Tripura in terms of Rule-3 of AIS (DA Rules 1972) subject to the terms and conditions laid down in the GOI office memo referred to above. This enhanced rate of DA is applicable as DA/DR on their revised Pay/Pension from the same date and on the same terms and conditions in respect of Serving members of Tripura Judicial Service and retired Tripura Judicial Service also.

OFFICE MEMORANDUM

Subject: Payment of Dearness Allowance to Central Government employees - Revised Rates effective from 1.1.2011.

The undersigned is directed to refer to this Ministry's Office Memorandum No. 1 (6)/2010-E-II(B) dated 22nd September, 2010 on the subject mentioned above and to say that the President is pleased to decide that the Dearness Allowance payable to Central Government employees shall be enhanced from the existing rate of 45% to 51% with effect from 1st January, 2011.


2 The provisions contained in paras 3, 4 and 5 of this Ministry's O.M. No. 1 (3)/2008-E-II(B) dated 29th August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.

3 The additional instalment of Dearness Allowance payable under these orders shall be paid in cash to all Central Government employees.

4 The payment of arrears of Dearness Allowance for the months of January and February, 2011 shall not be made before the date of disbursement of salary of March, 2011.

5 These orders shall also apply to the civilian employees paid from the Defence Services Estimates and the expenditure will be chargeable to the relevant head of the Defence Services Estimates. In regard to Armed Forces personnel and Railway employees separate orders will be issued by the Ministry of Defence and Ministry of Railways, respectively.

6 In so far as the persons serving in the Indian Audit and Accounts Department are concerned, these orders issue after consultation with the Comptroller and Auditor General of India.
