Office Memorandum

Subject:- Renewal/Revision of pension/ family pension of Civil Pensioners/family pensioners of State Govt retired prior to 01.01.2006-Acceptance of recommendation of U.P.Pay Committee -2008-on account of.

The undersigned is directed to say that the Governor of U.P., while accepting the recommendation of U.P.Pay Committee 2008, has been pleased to issue orders in regard to the renewal/revision of pension of all civil pensiones/family pensioners retired/expired prior to 01.01.2006, as under:-

2- These orders shall apply to all Civil pensioners/family pensioners of State Govt. (who are drawing pension/family pension sanctioned under U.P. liberalised Pension Rules 1961, U.P. Retirement Benefit Rules, 1961, New Family Pension Plan 1965 & Govt order No. Sa-3-969/X-933/86 dated 08.08.1986). These orders shall also apply to pensioners drawing pension under Disabled pension & Extra Ordinary Pension Rule (except extraordinary pension of non-govt pensionrs). However, these orders shall not apply to retired High Court Judges, Chairman/members of Public Service Commission. non-govt. servant of Education deptt, Local Bodies & Public undertakings,

3- In these orders:-

- a) Existing pensionrs'/family pensioners' means those pensioners who were
 drawing/entitled for pension/family pension on 31.12.2005 under State Govt Rules.
- b) Existing Pension means the basic pension (inclusive of commuted portion, if any) due on 31.12.2005. It covers all classes of pension mentioned in para 2 above.
- c) Existing Family Pension means the basic pension which was admissible on 31.12.1995 to the family pensioners at the rated mentioned in G.O.no.Sa-3-657/X-900/78 dated 10.05.1978 under New Family Pension Schenfe or G.O.no. Sa-3-1563/X-921/81 dated 03.11.1981 or on 31.12.05 to the family pensioners governed by G.O.no.Sa-3-969/X-923/85 dated 08.08.1986
- 4-(1) The pension/family pension of existing pre-2006 penioners/family pensioners will be consolidated w.e.f. 01.01.2006 by adding together:-

(i) Existing pension/family pension

(ii) Dearness pension, wherever admissible

- (iii) Dearness Relief upto AICPL 536 (based year 1982.100)i.e.@ 24% of Basic pension/family pension plus dearness pension as admissible vide GO no. Sa-3-1746/X-2005-308/2004 dated 02.12.2005 allowing merger of 50% D.R. into D.P.
- (iv) Fitment weightage @ 40% of the existing pension/family pension.

Where the existing pension in (i) above includes the effect of merger of 50% of DR, the existing pension for the purpose of fitment weightage will be recalculated after excluding the merged DR of 50% from the pension.

The amount arrived at will be regarded as Consolidated pension/ family pension w.e.f. 01.01.2006.

The fixation of pension will be subject to the provision that the revised pension, in no case, shall be less than fifty percent of the minimum of pay in the pay band plus the grade pay corresponding to the pre-revised pay scale from which the pensioner had retired. Where the eligible service is less than 33 years, this amount will be reduced proportionately but in nó case it will be less than Rs. 3500/-per month

Likewise the amount of family pension w.e.f. 01.01.2006 will not be lower than the thirty percent of the total of the minimum of the pay band plus grade pay corresponding to the pay seale of pre-revised pay scale of the Govt. Servant but in no case it will be lower than Rs. 3500/- per month.

4-(2) Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion will be deducted from the said amount while making monthly disbursements.

4-(3) Prior mimimum/maximum limit of pension/family pension as Rs. 1275 & Rs. 13000/- respectively will become Rs. 3500 & Rs. 40,000 w.e.f.01.01.2006

4-(4) The quantum of pension/family pension admissible to old pensioner/family pensioner shall be increased as follows:-

ge of Pensioner/family Pensioner Additional quantum of Pension •	
From 80 years to less than 85 years	20% of revised basic pension/family pension
From 85 years to less than 90 years	30% of revised basic pension/family pension (
From 90 years to less than 95 years	40% of revised basic pension/family pension
From 95 years to less than 100 years	50% of revised basic pension/family pension
100 years or more	100% of revised basic pension/family pension

The amount of additional pension will be shown distinctly in the Pension Payment Order. For example, in case a pensioners is more than 80 years and his/her consolidated pension in Rs. 10000/- p.m., the additional pension will be noted as Rs.2000/-p.m. thereagainst. Likewise pension and additional pension will be shown as per above table. In above cases, date of birth of pensioner/family pensioner must be noted so as there occurs no problem in disbursement.

<u>4-(5)</u> The existing pensioners, who retired between 31.3.1985 and 31.12.1985 and are in receipt of "personal pension" will continue to receive the same as earlier & it will not be merged in the consolidation of pension.

4-(6) Since the consolidated pension/family pension arrived at includes dearness relief upto average index level 536 (1982-100 base year), dearness relief will be admissible thereon only beyond above index average in accordance with the revised scheme of dearness relief for which orders will be issued separately.

5- Where the consolidated pension/family pension works out to an amount less than Rs. 3500/- the same shall be stepped upto Rs.3500/-. This will be regarded as pension/family pension with effect from 1.1.2006. In the case of pensioners who are in receipt of more than one pension, the floor ceiling of Rs.3500/- will apply to the total of all pensions taken together.

5(1)-In case a pension has also been sanctioned under Civil Service Regulations to the pensioner who is in receipt of pension under U.P.Civil Services Extra-Ordinary Pension Rules, the total amount of both pension shall not exceed Rs.3500/-p.m. In case only disability pension has been sanctioned, the minimum pension will not be less than 3500/-p.m. Above limit will apply in those cases where 100% disability stands certified and for lower percentage of disability, the minimum limit will be reduced proportionately.

6- The employed/re-employed pensioners/family pensioners:-

The employed/re-employed pensioners/family pensioners are not getting dearness relief on pension at present under the extant orders, In their case the notional dearness relief which would have been admissible to them but for their employment/reemployment will be taken into account for consolidation of their pension as if they were drawing the dearness relief. Their pay will be re-fixed w.e.f.1.1.2006 with reference to consolidated pension becoming admissible to them. Dearness relief beyond 1.1.2006 will, however, not be admissible to them during the period of employment/re-employment.

7- Pension of Govt. Servant on absorption in public sector undertakings/autonomus bodies-

(i) Pension:-

Where the Government servants on permanent absorption in public sector undertakings/autonomous bodies continue to draw pension separately from the Government, the pension of such absorbces will be updated in terms of these orders. In cases where the Government servants have drawn one time lump sum terminal benefits equal to 100% of their pensions and have become entitled to the restoration of one- third commuted portion of pension as per Supreme Court Judgement dated 15.12.1995, their cases will not be covered by these orders.

(ii) Family Pension:-

In cases where, on permanent absorption in public sector undertakings/autonomous bodies, the terms of absorption permit grant of family pension, the family pension being drawn by family pensioners will be updated in accordance with these orders.

(iii)Procedure of disbursement:-

As regards arrears of pension w.e.f. 01.01.2006 to 30.11.2008, 20% thereof shall be paid in financial year 2008-09, 40% thereof in financial year 2009-10 and balance 40% thereof in financial year 2010-11. Arrear of pension, admissible in different financial years shall be paid to pensioners/family pensioners in cash. Pensioners/Family Pensioners above 80 years or more shall be paid arrears of pension in the current financial year itself.

In event of death of pensioner/family pensioner prior to receiving admissible amount of arrear of pension, the balance amount of arrear of pension (including instalments of following years) shall be paid immediately in lumpsum cash to the person authorized by the pensioner/family pensioner or legal heirs.
