Subject:- Modus operandi for payment of additional family pension to the old family pensioners of Teaching staff including Graduate Laboratory Instructors/Instructress, Librarians/Asstt. Librarians, Physical Instructors/Instructresses and equivalent category of employees of State Aided Non-Govt. Colleges including erstwhile Sponsored Colleges.

In continuation of this office circular No. Pen.Co-ordn/51/Vol-V/84 dated 29/7/2010, it is informed that the Higher Education Department, C.S. Branch in their Memo. No. 1165-Edn(CS) dated 25/8/2011(copy enclosed), have decided to accept the Voter's I.D. Card or PAN Card as proof of age of the aged family pensioners in addition to the documents mentioned in. Memo. No.492-Edn(CS)dated 16/6/2010 (circulated vide order dated 29/7/10 ibid) for the purpose of making payment of additional family pension in terms of .para 4.4. of Memo. No.561-Edn(CS) dated 9/9/2009.

All Pension Disbursing Authorities are, therefore, requested to make payment of additional family pension to the eligible family pensioner after satisfying the age of the concerned family pensioner from any of the documents mentioned above without referring the matter to the concerned Pension Sanctioning Authority.

## MEMORANDUM

Sub : Payment of additional quantum of family pension in terms of Memo. No. 561-Edn(CS) dt. 09.09.2009

The undersigned is directed to state that in terms of this Deptt's Memo. No. 561-Edn(CS) dt. 09.09.2009 read with clarification (ii) of this Deptt's Memo. No. 492-Edn(CS) dt 16.06.2010, it was provided that the following documents would be accepted as proof of age/date of birth for payment of additional quantum of family pension in completion of 80 years and above :

) Certificate of the School Final Examination or equivalent Examination;

ii) Certificate from any doctor belonging to West Bengal Health Service (WBHS).

2. It has now been brought to the notice of the Govt. that many of the aged family pensioners are not in a position to trace certificate of the School Final Examination or equivalent Examination. Moreover, obtaining certificate from any W.B.H.S. doctor is not being possible for many such aged family pensioners.

3. Considering the difficult in producing any of the above mentioned documents as proof of age by aged family pensioners, the Governor has now been pleased to decide that in addition to the documents mentioned in clarification (ii) of the Deptt's Memo. No. 492-Edn(CS) dt. 16.06.2010, the Voter's ID Card or PAN Card will also be accepted as proof of age of the family pensioners for the purpose of being entitled to additional quantum of family pension.

4. All other conditions laid down for the purpose in this Deptt's Memo. No. 492-Edn(CS) dt. 16.06.2010 will remain unchanged.

5. Onwards additional quantum of family pension shall be paid directly by the Disbursing Officer on the basis of the documents mentioned in this Deptt's Memo. No. 492-Edn(CS) dt 16.06.2010 and in this order without referring the matter to the concerned Pension Sanctioning Authority.

6. The Treasury Officers/Drawing and Disbursing Officer shall take adequate caution to verify the genuineness of the age proof certificates/other documents. If any confusion arises in regard to the authenticity of age the matter may be referred to Finance Deptt., Pension Branch for decision.

7. This order issues with the concurrence of Finance Deptt., Pension Branch vide their U.O. No. 409-F(Pen) dt. 22.07.2011.
