

Subject:- Dearness Relief for the retired State Judicial Officers
at the revised rate enhanced from 45% to 51% with effect
from 01/01/2011 whose pension has been revised as per
recommendation of Padmanabhan Committee.

In continuation to this office circular No Pen.Co-ordn./65 Vol.IV/221 dated 21/01/2011, it is stated that the Government of West Bengal Judicial Department under their circular letter No 4083 – J dated 24/05/2011 has enhanced the rates of dearness relief from 45% to 51% with effect from 01/01/2011 payable to the retired Judicial Officers/family pensioners (whose pension/family pension has already been revised in terms of G.O. No 7014 – J and G.O No 7012 – J both dated 25/10/2010).

Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

All Pension Disbursing Authorities including Public Sector Banks are requested to make necessary arrangements for payment of dearness relief at the revised rate of 51% with effect from 01/01/2011 to the above mentioned categories of pensioners/family pensioners after making proper adjustment of overpayment/under payment, if any.
