Subject:- Grant of Ex-gratia payment to the pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission for the year 2011

Govt. of West Bengal, Higher Education Deptt., C.S. Branch in their Memo No. 1375-Edn(CS) dated 14/9/2011 read with Memo.No. ED-505/2011 dated 8/11/2011 of Govt. of West Bengal, Education Directorate have sanctioned ex-gratia grant of Rs.800/- (Rupees eight hundred) only in lump per head to all pensioners / family pensioners of Non-Govt Colleges, Day Students Home & West Bengal College Service Commission including the holders of provisional pension who retired prior to 30.09.2010 and also the pensioners who retired or died after 30.09.2010 but prior to 01.9.2011 and are not eligible to receive adhoc bonus.

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension alongwith relief did not exceed Rs.20,000/-(Rupees twenty thousand) as on 31<sup>st</sup> March 2011. The benefit is not admissible to those who are entitled to adhoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or exgratia payment in lieu thereof during the current year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.800/- (Rupees Eight hundred) only to the above categories of pensioners / family pensioners keeping in view the instructions as mentioned above.
- 4. The charges on this account is debitable to the Head "2071-Pension and other retirement benefits 01-Civil-800-Other Expenditure".
- 5. In case of any doubt/difficulty, the matter may be referred to this office for clarification.
