Sub:-Time limit for exercising option for enrollment under the West Bengal Health Scheme

In continuation of this office circular No.Pen.Co-ordn/212/Vol-II/124 dated 8/9/2010 it is informed that Govt. of West, Finance Department, Audit Branch, Medical Cell in their Notification No. 8219-F(MED) dated 19/8/2011 extended further benefit of Health Scheme in the following manner:-

- a) The retired State Govt. employees who were already enrolled under the West Bengal Health Scheme at the time of retirement will be deemed to be remaining under the scheme with effect from the date of retirement unless he/she opts out of the Scheme
- b) The concerned Pension Sanctioning Authority will issue fresh Identity Card under the Health Scheme as pensioner to the retired employee whose pension has already been settled. The Pension Sanctioning Authority will also issue a Temporary Family Permit for those pensioners who will not get P.P.O. No. at the time of retirement. Such Permit will remain valid till pension is settled.
- c) The retired State Govt. employee, if opts out of West Bengal Health Scheme will get medical relief @₹300/- p.m and will not be entitled to get any facilities under the Scheme. Such retired State Govt. employees will not be allowed to enroll their name again under the West Bengal Health Scheme in future.
 - d) This order will be effective from 1/8/2011

- 2. Besides, the Govt. of West Bengal Finance Department, Audit Branch, in their Notification No. 8435-F(MED) dated 29/8/2011 have also extended the time limit upto 31/3/2012 for the retired State Govt. employees to complete their enrolment under the West Bengal Health Scheme 2008 and stated as follows:
 - a) The retired Govt. employees who will not enroll their names under the West Bengal Health Scheme 2008 by 31/3/2012, will not be eligible to get the benefit of the Scheme in future.
 - b) The retired Govt. employees, enrolled under the West Bengal Health Scheme 2008 will not be eligible to be enrolled again if he/she opts out of the Scheme for whatever reason.
- 3. All Pension Disbursing Officers are, therefore, requested to display the fact on the Notice Board for information to the State Govt. pensioners to facilitate them to decide on the matter regarding availing of the benefits of medical
