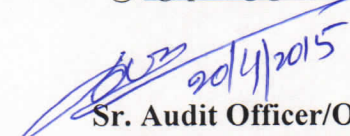

The vendors shall quote their competitive rates applicable throughout the financial year 2015-16 to arrange for refilling of the computer printer cartridges/ribbons as per the requisitions/indents sent by this office from time to time. The list of computer cartridges/ribbons etc., required refilling for the office use are listed in the annex (price schedule) enclosed and the service providers are requested to indicate item-wise rates against each and furnish the quotations in a sealed cover. The following are the terms & conditions prescribed for the limited tender.

1. Rates quoted should be inclusive of all taxes and incidental expenses for delivery at site(office).
2. Vendors should have proficiency in refilling the computer cartridges and sufficient experience in handling the related work precisely. Delivery of the refilled cartridges/ribbons should be made within 24 hours of the indent.
3. Refilling of cartridges/ribbons should be done as per the indents/requisitions placed with the vendors from time to time on annual rate contract basis and the rates shall be valid for one year upto 31.3.2016.

The sealed quotations should reach the undersigned on or before **28.4.2015** by **4-00 pm** and the same will be opened immediately in the cabin of the Senior Audit Officer/OE, Ground Floor, D-block of the office building. The prospective vendors responded to the tender may present themselves or authorize a representative at the time of opening the sealed quotations.
