**ORDER:**

In the reference 1<sup>st</sup> read above, the Ministry of Defence, Government of India have issued orders to allow the families of re-employed military pensioners to draw family pension from military side and civil side.

In the reference 2<sup>nd</sup> read above, the Home Department has submitted proposal on the lines of Government of India to allow the families of re-employed military pensioners to draw dual pension i.e. Family pension from military side and civil side duly deleting the Sub Rule 13 a (ii) & b of Rule 50 of Revised Pension Rules, 1980.

3. After careful examination of the matter, Government hereby order to allow the families of re-employed military pensioners to draw Family pension for the service in civil department in addition to Family Pension from Government of India for defence service.

4 Necessary amendments to the Telangna Revised Pension Rules, 1980 in this regard will be issued separately.
