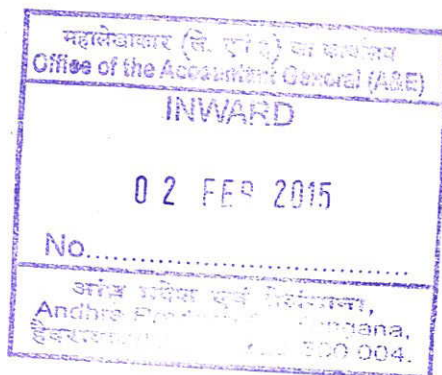

Sub: - GRANT OF DEARNESS RELIF TO STATE GOVERNMENT PENSIONERS/
FAMILY PENSIONERS-REVISED RATE EFFECTIVE FROM 01/07/2014

In pursuance to the Ministry of Personnel, Public Grievances & Pensions, Govt. of India's OM No. F. No. 42/10/2014-P & PW(G) dated 29th September, 2014, on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the State Government Pensioners/ Family Pensioners shall be enhanced from the existing rate of 100 % to 107 % with effect from 1st July 2014, in the following manner :-

(i) The additional installment of Dearness Relief (DR) shall be paid in cash along with the Pension/ Family Pension in respect of all State Government Pensioners/ Family Pensioners from the month of January 2015 onwards.

(ii) The arrears for the period from 1/7/2014 to 31/12/2014 shall also be paid in the month of January 2015.

2. All others terms and conditions as enunciated in Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners Welfare, Govt. of India's aforesaid OM shall remain unchanged.
