Subject: - Granting of Interim Relief to ret'd. Officers / Family Pensioners of Bihar Judicial Services w.e.f. 1.1.2016 – reg.

Keeping in view the recommendations of IInd National Judicial Pay Commission honorable Supreme Court has passed order on civil writ petition no. 643/2015 dt. 27.03.2018 to grant interim relief on pay & pension of Subordinate Judicial officers.

2. Hence, keeping in view the recommendations of IInd National Judicial Pay Commission Superme Court has passed order dated 27.03.2018 to grant interim relief to retired officers of Bihar Judicial service from 01.01.2016.

- i. Benefit of 30% hike in basic pension / Family Pension will be provided to all ranks and grades of retired Judicial Officer.
- ii. Interim Relief will be considered as a separate component. No D.A. will be pay on it. Hence, Interim Relief will be paid for basic pension only excluding Interim relief.
- iii. Payment of Interim Relief on pension will commence from May – 2018. Calculation of arrears will be made from 01.01.2016 and payment will be made on 30.06.2016.
- iv. After issue of final orders, the amount of Interim Relief already paid will be adjusted from the final amount, to be paid.
