

Aizawl, the 30th July, 2013

Subject: Increase of Dearness Relief from 72% to 80% to the Mizoram Government Pensioners/Family Pensioners with effect from 1.7.2013.

The undersigned is directed to refer to this Department's Office Memorandum No.G.17011/6/2010-F.APF dt. 26.2.2013 enhancing Dearness Relief @ 72% and to convey that the Governor of Mizoram is pleased to grant enhancement of Dearness Relief @ 8% from the existing rate of 72% to 80% to the Mizoram Government Pensioners and Family Pensioners with effect from 01.07.2013.

2. The enhanced Dearness Relief @ 8% shall be paid in cash to all Pensioners/Family Pensioners of Government of Mizoram who continue to draw Pension/Family Pension.

3. Payment of Dearness Relief involving a fraction of rupees shall be rounded off to the next higher rupee.

4. Payment of enhanced Dearness Relief should be made in Indian rupee (INR).


