Vide No. FIN/Rop/Rel-8/87/Vol-II dated 26/10/10 standing order of release of Dearness Relief to the Nagaland, State Government Pensioners/ Family Pensioners as and when sanctioned by the Government of India without any further order from the State Government or authorization from the Accountant General has been kept in abeyance till further notice (vide Finance Department, Government of Nagaland No.FIN/ROP/REL-8/87/(Vol.II) dated 26th February 2016). In future for Revision of Dearness Relief, separate authorisation will be issued as and when the same is revised by the State Government of Nagaland.
