Grant of **FIXED MEDICAL ALLOWANCE** to Pensioners and Family Pensioners of Union Territory of Puducherry - Revised rate effective from 01-12-2018 - Orders - Communicated.


1. The Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Pension & Pensioners' Welfare), New Delhi in its O.M. No.4/34/2017-P & PW (D), dated 19/07/2017 have revised the rate of **Fixed Medical Allowance** payable to the Central Government Pensioners/Family Pensioners residing in areas not covered under Central Govt. Health Scheme administered by the Ministry of Health & Family Welfare and corresponding Health Schemes administered by other Ministries/Departments for their retired employees for meeting expenditure on their day-to-day medical expenses that do not require hospitalization, with effect from 01-07-2017 at the rate of Rs. 1,000/-p.m.

2. The Government of Puducherry has communicated the Orders *ibid* for extending the revised rate of **Fixed Medical Allowance** Pensioners/Family Pensioners of the Union Territory of Puducherry vide L.D. Note/Office Memorandum, No.G.12011/FD/F3/A2/2018, dated 10/12/2018 of the Finance Department, Puducherry with prospective effect from 1st December 2018.

3. I am therefore to authorize you to effect payment of **Fixed Medical Allowance** at the revised rate of Rs.1,000/-p.m. with effect from 01-12-2018 to all eligible Pensioners/Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks/Treasuries/Sub-Treasuries under your control subject to conditions governing the grant of **Fixed Medical Allowance** as enunciated in the Government of India Office Memorandum aforesaid.
