I am to refer to the G.O and letter cited on the subject mentioned above and to communicate hereunder the amount of premium to be deducted for the second year 2019-2020 (3<sup>rd</sup> and 4<sup>th</sup> instalment) from the pensioners/family pensioners who have opted and enrolled under the “Contributory Medical Benefit Scheme” for the retired pensioners/family pensioners.

2. Premium calculated for the second year as per para 3 of the G.O.Ms.No.12 and serial No.7 of the terms and conditions attached to the said G.O. Amount of premium Rs.3870/- + applicable G.S.T i.e 18% = Rs.697/- (3870 + 697 = 4567/-) for the second year. The 3<sup>rd</sup> and 4<sup>th</sup> instalment = 2283.5 rounded to 2284/ per instalment.
