Subject: - Regarding Interim Relief on Pension / Family Pension to retired officers
Of Rajasthan Judicial Service.

Sir,

With reference to the subject cited above, it is to state that orders have been issued vide order no. F 10 (5) law / 2018 dated 21.05.2018 of state government law and legal matters department to grant 30 percent Interim Relief Per month on basic pension / family pension to retired officers of Rajasthan Judicial Service from 01.01.2016 (copy enclosed). The arrangement for the payment of 30 percent Interim Relief on basic pension / family pension to retired officers of Judicial Service & family pensioners, may be made from 01.01.2016 on date of commencement of pension (whichever is later) as per the following conditions –

- 1) D.A. will not be paid on the above Interim Relief .
- 2) If the benefit has been provided to a retired judicial officer and family pensioner by fixing pension /family pension under Seventh pay as per order/ circular/notification dated 30.10.2017 or 09.12.2017 issued by finance department of state government, and Interim Relief has been given thereon, the above Interim Relief is to be adjusted out of the excess amount paid earlier by adjust pension/ family pension fixation which had been made earlier.
- 3) In compliance with Supreme Court orders, it is requested to calculate Interim relief from 01.01.2016 which is payable from June 2018 along with pension and arrears. This may be ensured.
- 4) A software may be developed for showing separately the payment of above Interim Relief. All bankers and treasuries are requested to show this payment of IR separately in their scroll along with date and period.
- 5) Regular payment of IR from June 2018 may be ensured and when pay scales are announced this IR may be adjusted.

Top priority may be given to this please.
