The undersigned is directed to enclose herewith a copy of the office Memorandum issued from GOI, Ministry of Finance, Department of expenditure vide No.1/3/2008-E.II(B) dated 9th November, 2016 regarding rates of enhancement of DA applicable to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6th Central Pay Commission w.e.f.01.07.2016.

All Heads of Departments/ Heads of Offices concerned are, therefore, requested to arrange payment of DA as per the above enhanced rates of DA i.e from 125% to 132% w.e.f. 01-07-2016 to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6th Central Pay Commission. This enhanced rate of DA is applicable as DA/DR on their pre-revised Pay/Pension from the same date and on the same terms and conditions in respect of serving members of Tripura Judicial Service and retired Tripura Judicial Service also.
