Subject : Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal revised rate effective from 01/07/2023 on pre-revised pension/family pension

The Government of West Bengal, Judicial Department under their letter No. I/460242/2023-JJD/V/2A-14/17 dated 08/12/2023 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 221% to 230% with effect from 01/07/2023 on pre-revised pension/family pension.**

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.V/23 dated 18/05/2023, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ **230%** to the above category of pensioners / family pensioners with effect from **01/07/2023** where pension/family pension has not been revised as per instruction of this office circular No. Pen. Co-ordn./65 Vol. V/94 dated 27/09/2023, after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
